Academic Calendar is prepared well in advance. Teachers prepare lesson plans and also offer a model answer bank by way of e - content to all Students. Teachers are encouraged to use I.C.T aids and innovative teaching techniques apart from traditional teaching methods. Seminars & Educational visits are organized. Guest lectures are arranged for career guidance. The cross cutting issues like Gender, Environment and sustainability, Human values and professional Ethics are integrated in curriculum. The college believes in healthy environment for all students. The college has included society for creation of opportunity through proficiency in English and Environmental studies for first year Arts and Commerce students. Various committees like Grievance Redressal Cell, Anti Ragging Committee take care of student issues. The college conducts various awareness programmes through NSS & Samudayik Sevadhara to instill human values. The Eco Club ensures that plantations on the campus are well maintained. To pay homage to the 48 pulwama Martyrs the college has taken a unique activity under the category 'Green Tribute' and planted 48 saplings in the campus which is most appreciable.

The Institution assesses the learning levels of the students basing on the HSC results and through induction programmes. The Teaching learning methods adopted by the faculty members include lecture method, interactive method, project based learning, computer assisted learning, experiential learning. The teaching learning activities are made effective through illustration and audio visual lectures. The teachers have prepared model answer banks along with recorded lectures on specific topics and made available for easy access on the college you tube channel which is a good practice. ICT enabled teaching is followed. The college is conducting summer camps to inculcate valuable job skills among the students. The college is offering 10 summer courses during vacations. Workshops are arranged on skill development, communicative English, personality development, Indian culture. Advanced learners are encouraged to enroll in MOOC courses. Online submission of assignments is adopted in the department of English and Computer Science. Learning has been made student centric through various methods. Teaching Learning activities are made effective through illustration and audio visual lessons. Learning is made interactive through group discussion, role play, quiz, educational games and discussion on current affairs. Student seminars are organized on topics related to their curriculum to enrich their experience. Audio Visual teaching, online assignments, project work, Film shows are some of the learning processes of the institution. Students are encouraged to see educational channels on TV. Students are encouraged to submit their assignments through e mail which is an innovative teaching method of the institution. As per the University guidelines the institution adopts comprehensive continuous evaluation (CCE). Performance of students is monitored by the Head of the Department and the necessary feed back is given to the concern faculty. Students are made aware of the evaluation process during

the induction programmes at the beginning of the semester. Result analysis is done by the department after every CCE Test. Performance of the students is monitored by the Head of the Department. Reappearing / Re assessment scheme is available to the students as per University guidelines. The programme outcomes are measured by conducting 3 comprehensive continuous examinations in a semester. The average pass percentage of the student is 62.5. The corrected answer scripts of CIE are distributed to the students for verification, any grievances are redressed immediately. The grievances with regard to SEE will be redressed by the University. The college follows the academic and administrative calendar given by the University. All academic activities and examinations schedule is followed according to the University guidelines. The Institution has clearly stated outcomes of programmes by following different mechanisms. The Programme outcomes and course outcomes are kept available in college website and with concerned department heads. The learning outcomes are uploaded in website. Learning outcomes are communicated through IQAC and departmental meetings and through study circles. The Institution is listing out the career opportunities for all programmes to enable the stake holders to identify and select the subject of their choice. The students are able to understand the nature and basic concepts of education through programme specific outcomes. The college is measuring the students programme outcomes and programme specific outcomes by conducting 3 comprehensive continuous examinations in a semester.

The institution has created an Eco system for innovation and for transfer of knowledge. The faculty members are encouraged to take up research activities utilizing the existing facilities. The college has research committee to monitor the research activities. Three research guides have produced 15 Ph.Ds. Out of them, five were awarded during last 5 years. 50 articles in Journals and eight books were published. Out of 11 permanent teaching staff, 9 faculty members have Ph.D., degree as highest qualification. The college has organized an International Seminar on Henry David Thoreau and Indian thought 'during 2017-18. The institution is extending community services through NSS, YRC and a Society named Samudayik Seva Dhara – Community Service Society (CSS). The committee organize programmes in the neighbourhood community to create awareness among the different villages. Activities like, Health Awareness and Blood donation camps were conducted. The Institution adopted a village and a Government school and providing assistance. Apart from regular NSS activities the college has done Open Defecation Free (ODF) campaign. Through Indian Red Cross Society and Red Ribbon Club social activities are carried out. The Institution has conducted different events under extension activities during last five years.

The Institution has created good infrastructure facilities in the campus for effective teaching and learning. The Institution has 14 class rooms, 2 computer labs with 71 computers, Assembly hall and Audio Visual conference room. Digital Education and Learning Laboratory (DELL). Library is partially automated. It has 58,000 books, 3 journals, 27 magazines and 100 e-books. 110 girls have been provided hostel accommodation and it is managed by Gurukul Trust. The Institution has facilities for outdoor games. Three courts are available. The college made yoga and meditation as regular practice for hostel students. The institution also has adequate facilities for cultural activities. The automation work in the library is still in process. It is partially automated. Library has good quantity of materials for competitive examinations. The College updates IT facilities with regular interval. The institution has procedures for maintaining and utilizing physical, academic sports facilities and buildings.

The Institution is encouraging the enrollment of the first generation women learners from nearby villages and under privileged sections of the society. The Institution provides operational autonomy in academic performance. The college motivates to organize co-curricular and extra curricular activities for the holistic development of the students. Academic Calendar is chalked out before the beginning of the Semester. The college has prepared perspective plan which incorporates agenda for over all development of the college. The organizational structure of the institution includes Governing Body, administrative setup. The Principal of the college is assisted by the Heads of the Departments in academic administration. The college office maintains the statutory records pertaining to students as well as teaching and non-teaching staff. The Principal of the College conducts periodical meetings with teaching and non-teaching staff for planning and execution. The college administration conducts periodical meetings of various bodies/committees and discuss various issues and accordingly

resolutions are passed. The college has initiated welfare scheme for teaching and administrative staff. Teachers are encouraged to publish articles in journals and books. Teaching staff is granted duty leave for participating in workshop, seminars and conferences. The self appraisal report of the staff are studied through SWOT analysis and appropriate recommendations are made to the concerned employees and adequate measures are taken to improve the quality of teaching and learning process. The management has appointed auditor for internal audit of the accounts. External audit is carried out by the office of the Commissioner of Higher Education, Govt. of Gujarat. The major resources of the institution is student admission fees and limited grants from UGC. The IQAC is taking efforts for enhancement in quality and sustenance in academic and administrative activities. Academic and administrative audit has been done. The learning outcomes of the institution instill confidence, employability, social upliftment, skill development and value based outlook towards life and living. After the first accreditation, the college has established IQAC and introduced Choice Based Credit System during 2010. Three skill based courses have been introduced. The college has organized one International Conference during the last five years.

The institution also arranged Karate Training and other self defense training programmes for the students. Students are also trained in disaster Management. The career counseling committe monitors the career needs of the students by arranging special programmes and training. The college has taken some amount of efforts in solid waste and liquid. The college has not yet taken

systematic measures for rain water harvesting. How ever, some arrangements have been made to collect rain waterand it is used for watering the plants. The institution encourages students to utilize the pedestrian friendly surroundings of the college. The college has set up an eco club to promote and monitor green practices in the campus. The college is planning to make its office paper less. The college conducts summer camps and awareness programmes to maintain Eco friendly campus. The college has planted good amount of trees including medicinal plants. The college organizes national festivals to inculcate patriotism among students. The Institution is maintaining transparency in financial, academic and administrative matters. The college is imparting value education through prayer, yagna and study circle activity. The institution promotes rural women empowerment which is the main thrust area of the institution.

#### Strength

The college has Academic flexibility both horizontally and vertically. Lateral entry for BA/BCOM and credit transfer facility are permitted by the University. 12 short term skill based Add on courses help the students to co-up with latest trends. 3 UGC NSQF Add on courses is an extra benefit to the students. Well equipped laboratories and computerized library with internet facility, ICT enabled teaching, e-learning, organizing seminars and workshops and following both oral and online feed back system are some of the strengths of the institution. Good infrastructure facilities and forming of 7 study circles and 7 societies, career counseling and development centre helps the students in curricular, co-curricular and extra curricular activities are also the strengths of the institution. Lack of research culture, consultancy services, tie ups with industries and N.G.Os., limited member of placements, lack of permanent administrative staff are some of the weaknesses. The percentage of teachers participation in academic bodies is very less. Alumni association has not registered. Academic flexibility in curriculum, need based and skill oriented training for employment, more number of study circles and organization of co-curricular and extra curricular activities are some of the opportunities.

Retraining the students and controlling the dropout rate, improving communication skills of the first generation students, improving consultancy services and providing placements are the challenges to the institution.
